MAVIC'S TRANS-PROVENCE VIDEO CONTEST ("the Contest")

OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. ENTRY IN THIS CONTEST CONSTITUTES YOUR ACCEPTANCE OF THESE OFFICIAL RULES. EACH PRIZE WINNER IS ONLY ELIGIBLE TO WIN ONE PRIZE IN THE CONTEST.

Sponsor: Mavic, Inc., a Delaware corporation, with a principal office at 17 Parkridge Road, Haverhill, MA 01950 ("Sponsor").

1. Eligibility: The Contest is open only to permanent, legal residents of the fifty (50) United States and the District of Columbia, and Canada excluding the Province of Quebec (the "Territory"), and who are at least eighteen (18) years old at the time of entry, have internet access as of June 15, 2013. Employees of Mavic, Inc. and any of its respective related companies, parents, subsidiaries, affiliates, and agents and any agencies or other companies involved in the development or execution of the Contest or production or distribution Contest materials, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Contest is subject to all applicable federal, state, provincial/territorial laws and local laws and regulations. The Contest is void outside the Territory, in Puerto Rico, all US territories and possessions. Void where prohibited.

2. Agreement to Official Rules: By participating in the Contest, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of the Sponsor which are final and binding in all matters related to the Contest.

3. Timing: The Contest begins on June 15, 2013 at 12:00:00 a.m. Eastern Time ("ET") and ends on August 16, 2013 at 11:59:59 p.m. ET (the "Promotion Period"). Sponsor's computer is the official time-keeping device for the Contest.

4. How to Enter: There is one way to enter the Contest. During the Promotion Period, simply visit the web site located at http://www.pinkbike.com/contest/mavic-trans-provence (the "Website"), create a user account by following the instructions found on the Website or use your existing user account. Entrants will be required to submit (i) certain personal information including, but not limited to, the entrant's name, email address, and mailing address; and (ii) a two minute or less video that you feel best represents your passion for enduro and all-mountain riding. (entry personal information and video shall be collectively referred to as the "Entry Materials"). Once the video has been uploaded, complete all required information on the pop-up window and click 'submit'. Upon completion, one (1) automatic entry into the Contest will be provided to the entrant.

There is a limit of one (1) entry per person during the Promotional Period. Entries will not be acknowledged. Multiple entrants are not permitted to share the same user account. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different user

accounts, identities, registrations, or logins, or through any other methods, may void all of that entrant's entries and that entrant may be disqualified. The use of any automated system to enter the Contest is prohibited and may result in disqualification. In the event of a dispute as to any entry, the authorized account holder of the email address associated with the user account used to enter will be deemed to be the entrant. Potential Winners may be required to show proof of being the authorized account holder. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected entries, which are disqualified. ONLY THE FIRST ENTRY OF A GIVEN VIDEO WILL BE ELIGIBLE TO WIN A PRIZE. SUBSEQUENT ENTRIES OF IDENTICAL VIDEOS WITH BE DISQUALIFIED.

Entry Materials

By submitting Entry Materials you warrant and represent that: (a) it is an original work of authorship and that you have all necessary rights in and to the Entry Materials to enter the Contest, (b) it does not infringe upon the copyrights, trademarks, rights of privacy, publicity or other intellectual property or other rights of any person or entity, (c) you have obtained permission from any person whose name, image or likeness is used in the Entry Materials (if a minor is featured in the Entry Materials, permission must be obtained from the minor's parent/legal guardian), and (d) that publication of the Entry Materials via various media including Web posting, will not infringe on the rights of any third party rights. Submitting Entry Materials constitutes entrant's consent to give Sponsor a royalty-free, irrevocable, perpetual, non-exclusive license to use, reproduce, modify, publish, create derivative works from, and display such Entry Materials in whole or in part, on a worldwide basis, and to incorporate it into other works, in any form, media or technology now known or later developed, including for promotional or marketing purposes. Further, to the extent entrant may have moral rights in the Photo submitted, he/she hereby waives all such moral rights in favor of the Sponsor. not comply with these Official Rules or that otherwise contain prohibited, or inappropriate content as determined by Sponsor, in its sole discretion, will be disqualified.

Any waiver of any obligation hereunder by Sponsor does not constitute a general waiver of any obligation to entrants.

5. Winner Determination: Winners will be determined via the following process:

After the conclusion of the Promotional Period, a panel of judges composed of Mavic Enduro Athletes (the "Judges"), will judge the all eligible Entry Materials received based on the following criteria:

- Passion for Enduro/ All-Mountain Riding (up to 25 points);
- Entertainment Value (up to 25 points); and
- Overall Quality of the Video (up to 25 points).

The Entrant who submitted the Entry Materials which receives the highest score will be deemed the potential Prize Winner. In the event of a tie, the entrant who submitted the Entry Materials with the higher "Passion for Enduro/All-Mountain Riding" points will be deemed the potential Prize Winner; in the event of a tie in the number of "Passion for Enduro/All-Mountain Riding" points, the entrant who submitted the Entry Materials that received the higher "Entertainment Value" points will be deemed the potential Prize Winner of the more valuable Prize. The potential Prize Winner will be announced on or about August 19, 2013 on the Website. The potential Prize Winner will be required to provide Sponsor with an email address and a shipping address at time of notification.

ODDS OF WINNING DEPEND ON THE NUMBER AND CALIBER OF ENTRY MATERIALS RECEIVED DURING THE PROMOTION PERIOD. IF NO ENTRY MATERIALS ARE SUBMITTED IN COMPLIANCE WITH THESE OFFICIAL RULES, NO PRIZE WILL BE AWARDED.

6. **Prize Winner Requirements:** Receiving a Prize is contingent upon compliance with these Official Rules. Sponsor will contact the Prize winner within 1 week of the end of the Contest to coordinate the trip details. The winner must demonstrate to Sponsor, at least 10 days prior to departure, his/her possession of a valid passport, and other documentation allowing the individual to legally enter France.
