

2017 Pinkbike Fabric Box Hunt Giveaway

OFFICIAL RULES

Pinkbike Fabric Box Hunt Giveaway (the "Contest") is sponsored by Pinkbike, located at 1-37749 2 Avenue, Squamish, BC V8B 0S8, Canada (the "Sponsor").

There are prizes to be awarded monthly between August, 2017 and December, 2017. Number of and actual prizes for the contest will be determined by the sponsor and sponsor partners of the contest. Chances of winning depend on the total number of eligible entries received.

Sponsor partners of the contest includes: Fabric.

Who Can Enter:

1. The Contest is open worldwide.
2. The Contest is subject to all federal, provincial, and municipal laws, and is void where prohibited.

Timing:

4.  - d. Registration for the Contest is free.
6. To enter the Prize Draw Contest the entrant must click on entry button (CLICK HERE TO ENTER) found on the Contest Post - **contest page**. The entrants Pinkbike username will be automatically entered to win eligible prize. The entrant also acknowledges that they Follow @Fabriccycling Instagram Account..
 7. In order to be entered for each of the monthly Giveaway the user must visit the **contest page** and click on the enter for that month. Entering on one month will not gain you entry for all months. A monthly entry is required.
 8. Any use of an electronic device to enhance or alter entrants' odds of winning will count as a fraudulent entry. Entries that are fraudulent are not permitted and will be declared invalid.
 9. All entries become the property of the Sponsor and will not be acknowledged or returned. Receipt of entries for the Contest will not be acknowledged, and proof of submission of an entry will not be deemed proof of receipt.
 10. The Sponsor reserves the right to delete any entries or remove participants that are in violation of the Official Rules.

Grand Prize:

12. At the end of each monthly giveaway during the Contest Period names will be drawn at random to determine winners of monthly prize(s)
13. Winners will be notified via their Pinkbike account within 48 hours of their name being drawn. Winners will be asked to provide their Instagram user account name at this time.
14. In order to be verified the as the Winner, the selected entrant must respond to the prize notification email or Pinkbike message within seven (7) days of transmission, confirming that he/she:
 - a. (i) has read, understands and complies with the Official Rules;
 - b. (ii) releases and discharges the Sponsor; and
 - c. (iii) consents to the announcement of the Winner's name and the use by or on behalf of the Sponsor of the Winner's name and/or photograph and/or video for advertising and promotional purposes, without any further compensation to the Winner.

 - a. any erroneous lost, damaged, late, incomplete, misdirected, deleted, defective, or altered Contest registrations, regardless of the cause, including, but not limited to, failure of the Site;
 - b. any failure for any reason whatsoever of the selected entrant to receive a prize notification;
 - c. any changes in email addresses after Contest registrations are submitted; and
 - d. any computer, online, telephone, or technical malfunctions or errors that may occur, regardless of the cause.
