

# PINKBIKE TRAILFORKS CONTEST - CRANKWORX WHISTLER 2016 RULES

## A. WHO CAN ENTER

- 1. Entry is open worldwide to all persons above the age of nineteen years.
- 2. Direct employees of the Sponsor are not eligible. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

### B. HOW TO ENTER

- 3. NO PURCHASE IS NECESSARY. To register, eligible entrants must download and log into the Trailforks application. On first login, entrant must provide their first name, last name, email address, country of residence. Once logged in, each eligible entrant will receive one automatic entry per person for the contest.
- 4. Entry into the Trailforks giveaway will run from Friday August 12th 2016 Monday August 22nd 2016 (the "Contest Period").
- 5. The random draw of all eligible entries received between August 12 August 22 2016 will be held on or about Monday, August 22 2016 at the Sponsor's Headquarters.
- 6. Winners will be contacted via email. In order to be verified a winner, the selected entrant must; A. Respond to the prize notification email within three (3) days of transmission.
