- 8. The Contest is open from Sept 12th, 2017 at 9AM Pacific Standard Time ("PST") to Fri 15th, 2017 at 12:00 PM PST (the "Contest Period").

- 18. In order to be verified the as the Winner, the selected entrant must respond to the prize notification email or Pinkbike message within ten (10) days of transmission, confirming that he/she:
 - a. (i) has read, understands and complies with the Official Rules;
 - b. (ii) releases and discharges the Sponsor; and

 - a. any erroneous lost, damaged, late, incomplete, misdirected, deleted, defective, or altered Contest registrations, regardless of the cause, including, but not limited to, failure of the Site;
 - b. any failure for any reason whatsoever of the selected entrant to receive a prize notification;
 - c. any changes in email addresses after Contest registrations are submitted; and
 - d. any computer, online, telephone, or technical malfunctions or errors that may occur, regardless of the cause.

Winner is responsible for getting transport to/from departure airport, and any extra duties, taxes and fees including applicable insurance required for travel (including bike coverage).
- 26. Decisions of the Sponsors are final and binding.
- 27. By entering the Contest, participants consent to the Sponsor's collection, use, and disclosure of the personal information provided in the Contest registration for the administration of the Contest, including posting of the Winner's name and city of residence on the Sponsor's website. The Sponsor will use the Winner's personal information only for identified purposes, and protect the Winner's personal information in a manner that is. Entrants may write to the Sponsor and request that their information be removed from the Sponsor's records.
